Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On 05/05/2020 Detective Lt. Peter LaRocca received a phone call from a Manchester Detective regarding a stolen license plate. The license plate was stolen and was put on a stolen trailer, which was reported to Manchester Police Department. Lt. LaRocca later advised me of the theft and the victim's contact information. On 05/07/2020, at approximately 1200 hours the victim, Louis M Dowd called me back in regards to the theft. He explained that the stolen license plate (NJ [REDACTED] was stolen off his enclosed trailer, which is registered to his company, Creative Metal Contractors. The trailer was parked on the company's property for over a year and was disabled. He proceeded to state that the security cameras are contentiously recording and are not recorded just on motion detection. He did not view all the footage and only viewed the suspected time that the Manchester Detective requested. Mr. Dowd also advised me that he checked his security camera's, however he was unable to view anyone removing the license plate from the trailer. On 05/20/2020 Manchester PD, Toms River PD, and Berkeley PD conducted a court authorized search warrant at [REDACTED] in regards to stolen property. While conducting the search, Detective William Somers advised me that he located a black plastic storage container with orange spray painted CMC lettering. He then located a Milwaukee circular saw (with black CMC lettering) and two cardboard boxes (shipping address for Creative Metal Contractors) with 16 new Hilti screw boxes.
