Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

During the course of an investigation, a motor vehicle stop was conducted and the defendant provided these detectives a used hypodermic syringe containing suspect heroin in his pocket. The defendant stated the items in the back seat of the vehicle were stolen items out of the Home Depot in Lakewood. The defendant said his girlfriend (co-defendant) drove him to the stores where he stole the items. The value of the items from home depot valued at \$759.83, and this detective observed the defendant walk out of the store with the items in a shopping cart without paying for them on home depot footage. The defendant also stated he went to the Walgreens on Route 88 in Brick where he concealed a toothbrush and then drove to the Walgreens on Drum Point Road in Brick where he had his girlfriend the codefendant return the item for cash. The defendant said she drove her boyfriend to walgreens and home depot where he stole items.
