Sentencing Statement

It is, therefore, on 04/01/2021 **ORDERED and ADJUDGED** that the defendant is sentenced as follows:
Count 901: Defendant is sentenced to Probation for a period of one (1) year with the following condition: the defendant is sentenced to the custody of the Warden of the Ocean County Department of Corrections for a period of thirteen (13) days as a condition of Probation and is credited with sixteen (16) days of time served. This sentence is concurrent with W-2020-000192-1506 and 20-05-00519-A. If there is strict compliance and defendant does not have any new violations of probation and has not picked up new charges, the probation can end at the same time as the current probation.

Defendant is to continue and complete a Batterers' Intervention program prior to the expiration of his term of probation. Defendant is directed to comply with any and all terms and conditions as established by Probation, including, but not limited to, substance abuse evaluations, random urine screenings and recommendations for treatment.

Defendant is to pay monetary penalties as set forth on Page Two through Probation at a monthly rate of twenty-five (\$25) dollars commencing June 1, 2021 and then by the first (1st) day of the month thereafter. The court is applying three (3) of the jail credit days to satisfy monetary penalties, consequently, the \$50 VCCO and \$75 SNSF are deemed satisfied by application of three (3) days jail credit pursuant to N.J.S.A. 2B:12-23.1 and N.J.S.A. 2C:46-2(d).
