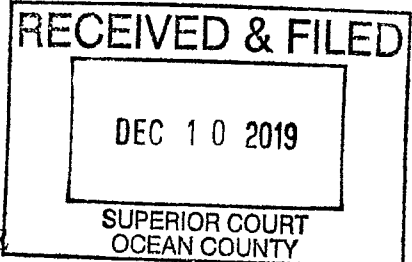

**COUNT ONE- FIRST DEGREE
MURDER**

The Grand Jurors of the State of New Jersey, for the County of Ocean, upon their oaths present that CIARA M. WILLIAMS, on or about September 29, 2019, in the Township of Brick , County of Ocean, and within the jurisdiction of this Court, did purposely or knowingly cause the death of Dennis Power or did purposely or knowingly cause serious bodily injury to Dennis Power resulting in his death, contrary to the provision of N.J.S.A. 2C:11-3a(1) or N.J.S.A. 2C:11-3a(2), and against the peace of this State, the government and dignity of the same.

**COUNT TWO – THIRD DEGREE
POSSESSION OF A WEAPON FOR AN UNLAWFUL PURPOSE**

The Grand Jurors of the State of New Jersey, for the County of Ocean, upon their oaths present that CIARA M. WILLIAMS on or about September 29, 2019, in the Township of Brick, in the County of Ocean aforesaid, and within the jurisdiction of this Court, did possess a certain weapon, to wit a knife, with the purpose to use it unlawfully against the person or property of another, contrary to the provisions of N.J.S.A. 2C:39-4d, and against the peace of this State, the Government and dignity of the same.

**COUNT THREE – FOURTH DEGREE
UNLAWFUL POSSESSION OF A WEAPON**

The Grand Jurors of the State of New Jersey, for the County of Ocean, upon their oaths present that CIARA M. WILLIAMS on or about September 29, 2019, in the Township of Brick, in the County of Ocean aforesaid, and within the jurisdiction of this

Court, did knowingly possess a certain weapon, to wit a knife, under circumstances not manifestly appropriate for such lawful uses as it may have, contrary to the provisions of N.J.S.A. 2C:39-5d, and against the peace of this State, the Government and dignity of the same.

**COUNT FOUR – THIRD DEGREE
HINDERING APPREHENSION OF PROSECUTION**

The Grand Jurors of the State of New Jersey, for the County of Ocean, upon their oaths present that RAMELO C. ADONIS, on or about September 29, 2019, in the Township of Brick , County of Ocean, and within the jurisdiction of this Court, with the purpose to hinder the detention, apprehension, investigation, prosecution, conviction or punishment of another, Ciara M. Williams, for an offense, did provide or aid in providing a weapon, money, transportation, disguise or other means of avoiding discovery or apprehension or effecting escape, contrary to the provisions of N.J.S.A. 2C:29-3a(2) and against the peace of this State, the government and dignity of the same.

**COUNT FIVE – THIRD DEGREE
HINDERING APPREHENSION OF PROSECUTION**

The Grand Jurors of the State of New Jersey, for the County of Ocean, upon their oaths present that RAMELO C. ADONIS, on or about September 29, 2019, in the Township of Brick , County of Ocean, and within the jurisdiction of this Court, with the purpose to hinder the detention, apprehension, investigation, prosecution, conviction or punishment of another, Ciara M. Williams, for an offense, did suppress, by way of concealment or destruction, any evidence of the crime contrary to the provisions of N.J.S.A. 2C:29-3a(3) and against the peace of this State, the government and dignity of the same.

**COUNT SIX – THIRD DEGREE
HINDERING APPREHENSION OF PROSECUTION**

The Grand Jurors of the State of New Jersey, for the County of Ocean, upon their oaths present that CIARA M. WILLIAMS, on or about September 29, 2019, in the Township of Brick , County of Ocean, and within the jurisdiction of this Court, with the purpose to hinder her own detention, apprehension, investigation, prosecution, conviction or punishment for an offense, did suppress by way of concealment or destruction of any evidence of the crime contrary to the provisions of N.J.S.A. 2C:29-3b(1) and against the peace of this State, the government and dignity of the same.

**COUNT SEVEN – THIRD DEGREE
CONSPIRACY TO HINDER APPREHENSION OF PROSECUTION**

The Grand Jurors of the State of New Jersey, for the County of Ocean, upon their oaths present that CIARA M. WILLIAMS and RAMELO C. ADONIS, on or about September 29, 2019, in the Township of Brick, County of Ocean, and within the jurisdiction of this Court, with the purpose of promoting or facilitating the crime of hindering apprehension or prosecution of Ciara M. Williams, in violation of N.J.S.A. 2C:29-3a(2), N.J.S.A. 2C:29-3a(3), and N.J.S.A. 2C:29-3b(1) did agree that they or one or more of them knowingly would engage in conduct which would constitute the aforementioned crime.

The Grand Jurors aforesaid, upon their oaths, do further present that in pursuance of the said conspiracy, the following OVERT ACTS, among others, were committed:

1. On September 29, 2019 CIARA M. WILLIAMS and RAMELO C. ADONIS did conceal and/or destroy evidence of a crime by cleaning 2747 Hooper Avenue, Building 5, Apartment 6 in an effort to evade police detection.
2. On September 29, 2019 RAMELO C. ADONIS assisted CIARA M. WILLIAMS in disposing of a white Mercedes Benz C300 and using Uber for transportation in an effort to evade police detection.

All in violation of N.J.S.A. 2C:5-2, and against the peace of this State, the Government and dignity of the same.

**COUNT EIGHT – FOURTH DEGREE
TAMPERING WITH EVIDENCE**

The Grand Jurors of the State of New Jersey, for the County of Ocean, upon their oaths present that CIARA M. WILLIAMS and RAMELO C. ADONIS, on or about September 29, 2019, in the Township of Brick, County of Ocean, and within the jurisdiction of this Court, believing that an official proceeding or investigation is pending or about to be instituted, did alter, destroy, conceal or remove any article, object, record, document or thing of physical substance with purpose to impair its verity or availability in such proceeding or investigation contrary to the provisions of N.J.S.A. 2C:28-6(1) and against the peace of this State, the government and dignity of the same.

**COUNT NINE – FOURTH DEGREE
CONSPIRACY TO TAMPER WITH EVIDENCE**

The Grand Jurors of the State of New Jersey, for the County of Ocean, upon their oaths present that CIARA M. WILLIAMS and RAMELO C. ADONIS, on or about September 29, 2019, in the Township of Brick, County of Ocean, and within the

jurisdiction of this Court, with the purpose of promoting or facilitating the crime of tampering with evidence, in violation of N.J.S.A. 2C:28-6(1), did agree that they or one or more of them knowingly would engage in conduct which would constitute the aforementioned crime.

The Grand Jurors aforesaid, upon their oaths, do further present that in pursuance of the said conspiracy, the following OVERT ACTS, among others, were committed:

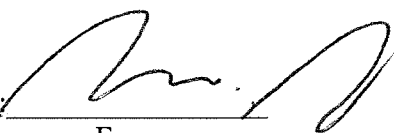

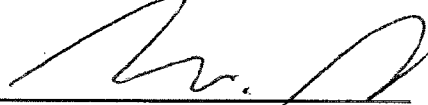
