On June 07th 2020 [REDACTED] responded to Brick Township Police Department in reference to an Invasion of Privacy complaint. [REDACTED] stated she lives at [REDACTED] Michael Paul Mattina. [REDACTED] said she had just became aware that Mattina had been video recording her and her family in their upstairs bathroom and posting it to a pornographic website.

[REDACTED] explained that she [REDACTED] was contacted by [REDACTED] who is in Puerto Rico and advised her that he was on a pornographic website called "MeWe" and he located sexual videos of his [REDACTED] and other family members. [REDACTED] said that he observed nude photos and videos of her [REDACTED], [REDACTED], [REDACTED] and his brother's girlfriend [REDACTED].

[REDACTED] said that she checked the website for the videos and upon finding them, she realized some of the videos were taken from the upstairs bathroom of [REDACTED] home. [REDACTED] stated some of the videos were of her and Mattina engaged in sexual intercourse from over 7 years ago. She stated some of the videos were made consensually, others were secretly recorded. [REDACTED] stated she never agreed to have them made public or posted to any website.

On June 08th 2020 Det. McCarthy #172 and I met with [REDACTED] at Brick Township Police Department. [REDACTED] provided me with the "MeWe" site information to the video's and photos then forwarded copies of the same to me. Upon showing me the videos and photos, [REDACTED] was able to identify everyone in the videos including her [REDACTED] and positively identify her upstairs bathroom as the location. The "MeWe" account was created by the user "UNAWARE LATINA WIFE".

[REDACTED] then showed me a small black cube shaped USB charging device with what appeared to be a pin hole camera in it. She stated after learning of the hidden camera she went into the bathroom and found this device plugged into an electrical outlet above the sink. When plugged in the camera would have the same view as the videos found on the website. I was familiar with the device from prior investigations and knew it to be a hidden camera device that can be recorded on an SD type card or via Wifi. The device was secured to be placed into property. While speaking with [REDACTED] she explained that Mattina stored the videos they made years ago on his cell phone and swore to her that he deleted them. She stated Mattina did not have a laptop or any other computers or devices other than his cellphone which she described as a black phone.

After filing the report and being granted a Temporary Restraining Order, Det. McCarthy and I responded to the residence with patrol units to serve Mattina. Upon arrival, we spoke with Mattina and read/explained the TRO to him before giving him a copy. In speaking with him, he agreed to come back to police headquarters to speak with us further. Mattina voluntarily turned over his only cell phone to Det. McCarthy until we arrived at Brick headquarters for an interview. At headquarters, Mattina was read and explained his rights as per Miranda and upon doing so, he wished to speak with an attorney before giving any statements. At that point, the interview was stopped and he was advised that we would be applying for a search warrant for his phone. Both the cell phone and black cube were brought

to the Ocean County Prosecutor's Office High Tech Crime Unit for a forensic analysis. A full forensic examination is pending.

On June 08th 2020 I was contacted by [REDACTED] who stated she was the daughter of [REDACTED] and had also found videos of herself on a pornographic website. [REDACTED] stated she was advised by her mother of what Mattina had done and decided to look on the Internet for any videos or photos of herself. [REDACTED] stated she found 2 videos on the website "Xhamster", under the username "Testo13". [REDACTED] stated the videos were filmed while she was naked in the bathroom, from someone standing outside of the bathroom window looking in from the back deck of the residence. [REDACTED] stated there were also several pictures and photos of [REDACTED]

On June 08th 2020 I sent out a Preservation Request to "MeWe.com" for account "UNAWARE LATINA WIFE" and on June 09th 2020 to "Xhamster.com" for account "Testo13". Subpoenas were then sent to "MeWe" on June 09th 2020 and "Xhamster" on June 10th 2020.

I received an email on June 10th 2020 from the legal team at "Xhamster", providing the email address [REDACTED] for username "Testo13". A subpoena was then sent to Google on June 12th 2020 for subscriber information for that email account. On July 02nd 2020 I received information from Google which provided the name Michael Mattina and phone number [REDACTED] associated with that email. The phone number provided by Google is the same phone number that [REDACTED] provided the police for Mattina when filing the initial police report and the same number Mattina gave to me at police headquarters prior to his interview.

On June 12th 2020 a search warrant was granted by Honorable Guy P. Ryan, J.S.C. for one black with silver trim Samsung Galaxy S7 IMEI#359755076431671, cellular facility number [REDACTED]. On June 29th 2020 the search warrant for cellular telephone [REDACTED] was executed by Det. Dotto of the Ocean County Prosecutor's Office High Tech Crime Unit. A full forensic examination is pending.

On June 30th 2020 a Communications Data Warrant was granted by the Honorable Guy P. Ryan, J.S.C. for all the stored electronic data and account information located at "MeWe.com" for user ID#5C8E3F5986C3D72DBDDF787D, utilizing email [REDACTED]

In June 30th 2020 I executed the CDW via email to "MeWe.com".

I received the information back from the CDW via USB Drive on July 07th 2020. The information provided the suspect's profile as the following: date registered was 03/17/2019, name Unaware Latina Wife, email address [REDACTED] and last log in 06/08/2020 at 18:01 hours. Information provided dates/ time for each time he created a post.

Videos/images of the victims [REDACTED] were posted several times from June 05th 2020 to June 08th 2020. Specifically, by sharing more than 6 videos and 2 images of [REDACTED] were posted to MeWe.com by "Unaware Latina Wife", which were viewable by others. The videos were taken inside the bathroom at [REDACTED] which I recognized from my observations of being inside the residence. Videos show the victim's intimate parts exposed.

Specifically, by sharing 13 videos and images of [REDACTED] were posted to MeWe.com by "Unaware Latina Wife", which were viewable by others. The videos appear to have been taken inside the bathroom at [REDACTED] and show the victim's intimate parts exposed.

There were 6 videos and 2 images posted of [REDACTED] which appear to be taken inside the bathroom at [REDACTED]. The videos/images show the intimate parts of [REDACTED] while she is nude. There were also written posts with the images/videos of [REDACTED] stating: [REDACTED] giving us a little treat" and [REDACTED] after shower, let's hear some nasty comments on what you would do to this 18 year old hot little bitch". It is important to note that a [REDACTED] birthday party was recently held at the suspect's home for [REDACTED] so the victims are confident suspect knew [REDACTED] was a minor and not 18.

The information also provided IP addresses. The last login IP address and most frequent used is [REDACTED] which is registered to Comcast.

On July 21st 2020 a Subpoena was sent to Comcast to provide subscriber information for the individual(s) assigned to that IP address. On August 11th 2020 I received the request back indicating that the IP address is registered to [REDACTED] who had resided at [REDACTED] with Mattina at the time of the incidents.

[REDACTED] was also able to provide personal emails between she and Mattina from as far back as 02/21/2018 with the email [REDACTED] with a picture of him in his profile.
