Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

One of the students in the SnapChat message showed Ptl. Myers screenshots of the messages, which included a photograph of a male holding (2) two long guns / firearms. Ptl. Myers compared the photograph of the male holding the firearms to [REDACTED] of Frankie Caserta Jr., and they appeared to be the same individual. The firearms appeared to be a semi-automatic rifle, and a short-barrel shotgun. Ptl. Myers then read the messages which included statements such as, ".one reason I shouldn't massacre pinelands?" and "Imma call pinelands and say there's an army of Crips coming to shoot it up...and there is...Around the end today." Ryan stated Caserta had previously indicated that he would be arriving at the school at 2 P.M., which is just before the schools normal dismissal time. Caserta used his last name of the SnapChat message and during the messages, Caserta told others to come to his house at 52 East Washington St. in Pleasantville, NJ (Caserta's LKA) and sent photos of himself with matched his DL [REDACTED].
