Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

The victim reported defendant and co-defendant were living with he and his wife for an extended period of time to help take care of his wife. While there, defendant and co-defendant somehow obtained possession of a credit card issued to him by Chase Bank (Card # [REDACTED]). Victim produced a copy of a credit card statement showing a balance of \$7073.15. Victim advised he only uses the credit card to pay for oil changes which he pays in full, and pays for everything else in cash. After receiving the bill he confronted the two defendants at which time they moved out which was some time back in July. He explained he called co-defendant a short while later and she advised not to worry about the charges and she would take care of it. Victim never heard from either subject again. Most of the fraudulent charges were from liquor stores, convenient stores, and pharmacy's in town. Several other charges were from Walmart in Brick NJ on 04/22/2020, 04/29/2020, 05/26/2020, and 06/04/2020. On 09/23/2020 this officer responded to Walmart in Brick NJ and met with loss prevention regarding the purchases. Receipts for the purchases revealed defendant, who was an employee of Walmart, utilized her employee discount card on two of the transactions which showed her name on the receipts. Two of the other receipts from 04/29/2020 and 05/26/2020 were for RX prescriptions at the pharmacy on location. A grand jury subpoena was later served upon Walmart for the RX prescription information which later revealed both were in defendant's name [REDACTED]. A spreadsheet later provided by Chase Bank Fraud Department showed a total of 171 fraudulent transaction with a total loss amount of \$6,148.83.

On 10/27/2020 this officer conducted a stationhouse interrogation with defendant during which time she advised victim gave she and co-defendant permission to utilize the credit card on all occasions. She admitted to being part of all purchases, whether she made them herself or drove co-defendant in her vehicle to make them. Defendant advised she never returned the card to the victim, and could not remember if she destroyed it or misplaced it. Victim was advised after the interrogation of defendant's statements, and again advised he never authorized either subject to make any purchases with his credit card.
