Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:
On 01/09/2021 at approximately 2054 hours Brick Police Officers responded to Dicks Sporting Goods for a report of a shoplifting in progress. The caller stated that two subjects concealed jackets in there backpacks. The subjects were described as a white male and female approximately thirty years old wearing backpacks
Upon our arrival we observed a white male and female, matching the suspects description, walking out of the store. The suspects, Diana Boback and Frank Cruz, were both wearing backpacks. While speaking to officers, Boback and Cruz admitted to concealing items in there backpacks and leaving the store without paying for the items.
