Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:
During the course of a shoplifting investigation, loss prevention attempted to stop the defendant and the defendant continued to slowly walk away. A detective displayed his duty badge advising the defendant to stop but the defendant shoved the shopping cart full of stolen items towards loss prevention officers, and ran pushing a detective attempting to flee from loss preventions and officers on scene. Detective attempted to place the defendant under arrest. During the altercation, the defendant used physically force in an attempt to flee and get away from being arrested. Additionally, two detectives received minor injuries and refused further medical attention. Search incident to arrest of the suspect yielded several pills located inside of his wallet suspected to be steroids.
