Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On January 19, 2019, the Lakewood Police Department took a call for service in reference to a credit card that was lost, and used by an unknown person after the owner realized it was not in her possession. The victim, Carolina Vasquez, found video surveillance at the Quick Check, 901 Cedar Bridge Avenue, Lakewood, New Jersey. The surveillance displays Ms. Vasquez dropped the card in question (marked 01-19-2019 Sat 14:27:53 in video surveillance) as she walked out of the entrance / exit door on the north side of the building.

Several customers walk through the door, and continue into the store. At "01-19-2019 Sat 14:312:46" on the video surveillance, a dark colored Ford Expedition pulls into the parking lot, directly in front of the door Ms. Vasquez exited and dropped her credit card. At "01-19-2019 Sat 14:32:03" on the video surveillance, Nicole Bairstow enters the door, immediately stepping on the misplaced credit card. Nicole drops an item, then picks up the item she dropped and the credit card she stepped on. Nicole does a transaction at the register (not with the misplaced card) then leaves.

Ms. Vasquez's missing credit card is later used at "Leisure Village Servic Lakewood/NJ" for the amount of \$30.00.

I am familiar with Nicole Bairstow from previous interactions. She is observed on video driving a black Ford Expedition, [REDACTED]

[REDACTED] I contacted Nicole on 2/6/2019 and asked her to come in for an incident. Nicole indicated that she would call back in ten minutes, but she has not returned my call. I left a message for Nicole on 2/7/2019 at approximately 1025hours. Nicole left a message. I have since left two messages, without a return call.
