While on patrol on the above date and time, I Ptl. Madera responded over to [REDACTED] in reference to an active domestic involving a male armed with a knife. Upon my arrival to the area I was able to locate the defendant walking west on [REDACTED]. Upon stopping Omar he proceeded to throw a closed black pocket knife over an adjacent fence. She continued Omar then became angry and struck her in the face with a closed fist causing visible redness and swelling. The victim's 12 year old son then intervened and began hitting Omar. Omar then proceeded to push the kid into the stove and lifted his shirt, attempting to blind him. Omar then pulled out a black pocket knife and threatened both individuals while stating "I'll kill you". The victim's son then proceeded to grab a kitchen knife and pointed it at Omar. Omar left the residence and was stopped by police shortly after.
