A forensic download of the defendant's cell phone and corresponding subpoena's to the TextNow mobile application revealed that the phone number utilized to make the bomb threat was issued to the defendant by the TextNow application and that the TextNow account was created by the defendant utilizing the defendant's email address. The forensic download showed that the defendant installed the TextNow application minutes before making the call and then subsequently deleted the applications minutes after ending the call. The download showed the defendant's cell phone being Geo Located to the area of the Jenkinson's Ride Park and time records show the defendant to be working at the ride park at the time of the incident.
