The Grand Jurors of the State of New Jersey, for the County of Monmouth, upon their oaths present that ABRAHAM CHAPNICK, on or about March 12, 2014, in or about the Township of Howell, County of Monmouth, and within the jurisdiction of this Court, did commit the crime of Leaving the Scene of a Motor Vehicle Accident Resulting in Death, while operating a motor vehicle and knowingly being involved in a motor vehicle accident, and then knowingly leaving the scene of the motor vehicle accident, under circumstances that violate N.J.S.A. 39:4-129, which motor vehicle accident resulted in the death of C.M., contrary to the provisions of N.J.S.A. 2C:11-5.1, and against the peace of this State, the Government, and dignity of the same.

SECOND COUNT

HINDERING APPREHENSION OF ONESELF

THIRD DEGREE CRIME

The Grand Jurors of the State of New Jersey, for the County of Monmouth, upon their oaths present that ABRAHAM CHAPNICK, on or about diverse dates between March 13, 2014 through March 17, 2014, in or about the Township of Howell, County of Monmouth, and within the jurisdiction of this Court, did commit the crime of Hindering Apprehension of Oneself, by, with purpose to hinder his own detention, apprehension, investigation, prosecution, conviction, or punishment for the crime of Knowingly Leaving the Scene of a Motor Vehicle Accident Resulting in Death, suppressing, by way of concealment or destruction, any evidence of the crime or tampers with a document or other source of information, regardless of its admissibility in evidence, which might aid in his discovery or apprehension or in the lodging of a charge against him, contrary to the provisions of N.J.S.A. 2C:29-3b, and against the peace of this State, the Government, and dignity of the same.
