On 06/12/2021 at approximately 1454 hours, Ptl. Albanese #257 and I responded to [REDACTED] in reference to a burglary. Upon arrival to the residence, contact was made with [REDACTED] the victims [REDACTED] husband. [REDACTED] advised his wife does not speak English fluently and would translate what had occurred. [REDACTED] advised at approximately 1205 hours, his wife had received a phone call from her daughter, the defendant. On this phone call, the defendant had asked [REDACTED] if she was home. The victim advised the defendant she was not and on her way to Home Depot. The victim returned home at approximately 1300 hours and began planting. When [REDACTED] returned home, he had entered the residence and went to the second floor. While at the second floor, he observed a bedroom window had been shattered and a blood trail went from the window into his bedroom. The blood trail then led to the closet and in the closet, approximately \$200.00 in currency had been removed. The blood trail then goes down the steps and out the back door. [REDACTED] showed officers blood on a fire extinguisher located in a close proximity to the window and showed officers a ladder that had blood on it as well. [REDACTED] believed their daughter, the defendant, had committed the burglary. [REDACTED]. I responded to 907 Cypress Avenue in an attempt to make contact with the defendant. While at the residence, contact was made with the homeowner Daniel Mizner Sr. who was just returning home from work. He was advised of the reason for our arrival and gave consent to enter the residence with him. On the door handle of the residence blood was observed. In the interior of the residence, blood was located on a sheet on the couch. Upon observation, Mr. Mizner stated the blood in question was not present when he had left for work. Mr. Mizner was asked who frequently stays at the residence beside himself and he advised only he, the defendant, and his dogs.
