Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

During a motor vehicle stop I requested the driver (Vera Griatzky) speak to me at the rear of the vehicle to address her suspended registration. While speaking with the suspect I observed multiple indicators of nervous behavior. While speaking with Griatzky, she advised me she just left the physical therapy facility near Brick Hospital because her front seat passenger, George Reed, just finished a physical rehabilitation session. Finding this statement to be odd since it was almost 1400 hours on 4th of July, I spoke with the front seat driver separately. When asked, Reed stated they had just left his mom's house. Due to the inconsistent stories and nervous behaviors, I requested a K-9 respond to the scene. Sheriff K-9 Officer Fennessey deployed his K-9 partner who gave a positive indication to the presence of an illegal narcotic. A search of the vehicle revealed a small quantity of marijuana located in the Griatzky's purse. In addition various prescription pill containers and pills which were not prescribed to her were located inside the vehicle
