Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

Units responded to the residence of [REDACTED] in reference to 9-1-1 call regarding an intoxicated male subject fighting with [REDACTED] who was the caller. Upon arrival, I met with the caller inside the residence who informed me his son was intoxicated and flipped a table damaging a tabletop glass globe figurine valued at \$300.00. He stated he moved the defendant into the garage where he began kicking the retractable garage door, damaging the bottom portion of the garage door. While on scene, I met with the defendant who was in the backyard and appeared intoxicated. The defendant stated he drank several shots of vodka and was arguing with [REDACTED] about a television program. The defendant stated he did not recall flipping the table or kicking the garage door but stated he may have fell into the table breaking the glass globe. The defendant's girlfriend was on scene and stated the defendant was arguing with [REDACTED] and observed him damage the globe and heard him kicking the garage door. The defendant's mother was also on scene and corroborated the accounts of the incident. The defendant was subsequently placed under arrest for Domestic Violence Criminal Mischief.
