Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:
On 5/21/21, at approximately 1532 hours, the resident of [REDACTED] was transported to the hospital for unknown medical issues. An additional resident, S [REDACTED] B [REDACTED], also left the residence after First Aid and Police officers left the seen. At 1547 hours, Walton Britton, who resides at 4 Hollycrest Drive, is seen on surveillance cameras exiting the property of [REDACTED], while carrying something in his hands. Again at 1620 hours, Walton is seen on cameras coming back up the street on the same path, and picking up small items off the street. Upon S [REDACTED] B [REDACTED] return to [REDACTED], she noticed a coffee can containing US Currency in the form of coins, and jewelry was missing from the residence. At 1830, during a traffic stop made by Det. Talty and Det. Person, Walton is wearing a women's ring on his finger which he stated he was trying to sell at Michelle's Gold. Walton also stated he was going to Stop n Shop to cash change out that was in a coffee container in the back seat. In speaking with neighbors on Hollycrest, they observed Walton picking up money he dropped after leaving [REDACTED]. Also in a statement from Jason Feliciano, who was driving Walton at the time of the traffic stop, he stated Walton told him he had taken the items from S [REDACTED].
