Based on statements made by involved parties and injuries sustained by victim, it was determined the defendant was the aggressor in the altercation. The victim (JB), as well as his wife, the defendants mother, believed the defendant had become upset due to them being together. As a result, she had started to throw golf clubs in their direction and engaged in a scuffle with her mother. After the scuffle had been separated, the victim had left the residence. When he returned to obtain his cell phone, the defendant struck him in the chest with the legs of a stool causing him to gasp for air.
