Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:
OFFICERS RESPONDED TO THE AREA OF 51 CAPRI DRIVE FOR A MOTOR VEHICLE COMPLAINT. UPON MY ARRIVAL, THE DEFENDANT WAS ENGAGING IN VIOLENT AND TUMULTUOUS BEHAVIOR WITH OTHER NEIGHBORS BY YELLING AND SCREAMING AT THEM AND MAKING THREATS TO HARM THEM. OFFICERS ADVISED THE DEFENDANT NUMEROUS TIMES TO CALM DOWN, HOWEVER THE DEFENDANT REFUSED OFFICERS COMMANDS. AT THAT POINT, OFFICERS ATTEMPTED TO PLACE THE DEFENDANT UNDER ARREST, HOWEVER THE DEFENDANT BEGAN TO RESIST SPECIFICALLY BY ATTEMPTING TO PULL AWAY FROM OFFICERS CONTROL THEN STIFFEN HIS ARMS AND TWIST HIS BODY AWAY FROM OFFICERS.
