Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

THE VICIMT WAS HIRED BY THE DEFENDANT TO MANAGE HIS SOCIAL MEDIA ACCOUNTS. THE DEFENDANT EXPRESSED HE WANTED TO BE IN A RELATIONSHIP TOWARD THE END OF JULY TO WHICH THE VICTIM DECLINED. AFTER THE VICTIM DENIED HIS REQUEST ON, AUGUST 8TH THE DEFENDANT HAD SHOWED UP AT THE VICTIMS PLACE OF EMPLOYMENT DUE TO THE VICTIM IGNORING HIS MESSAGES. THE DEFENDANT HARASSED THE VICTIM BY CALLING APPROXIMATELY 25 TIMES AND VERBALLY AGGRESSIVE WHEN HE DID LOCATE THE VICTIM. DESPITE SEVERAL REQUESTS FOR THE DEFENDANT TO LEAVE HE CONTINUED TO HARASS THE VICTIM. THE DEFENDANT HAD ULTIMATELY LEFT, HOWEVER HE ADVISED THE VICTIM HE WOULD ALWAYS SHOW UP WHERE SHE IS IF SHE DOES NOT ANSWER HIM. RECENTLY THE VICTIM EXPRESSED SHE NO LONGER WISHED TO MANAGE THE DEFENDANTS SOCIAL MEDIA ACCOUNTS AND SHE HAD BLOCKED THE DEFENDANT ON ALL SOCIAL MEDIA PLATFORMS AS WELL AS PHONE NUMBER. THE DFEDNANDT PROCEEDED TO CONTINUE COMMUNICATION BY FINDING A WAY TO UNBLOCK ALL OF HIS ACCOUNTS. THE DEFENDANT WAS ONCE AGAIN BLOCKED, HOWEVER THE DEFENDNAT BEGAN UTILIZING APPLICATIONS THAT GENERATE GHOST NUMBERS IN ORDER TO CONTINUE HARASSING COMMUNICATION WITH THE VICTIM. THE DEFEDNANT ALSO CREATED NEW SOCIAL MEDIA ACCOUNTS IN ORDER TO CONTINUE COMMUNICATION ONCE AGAIN. RECENTLY THE DEFENDANT BEGAN POSTING THE VICTIMS PERONAL INFORMATION TO INCLUDE HER PHONE NUMBER AND HOME ADDRESS. THE DEFENANT ALSO POSTED SEMIPROVACATE PHOTOS WHICH WERE TAKEN FROM THE VICTIMS PRIVATE INSTAGRAM ACCOUNT. THE INFORMATION AND PHOTOS WERE POSTED ON SEVERAL DIFFERENT SOCIAL MEDIA PLATFORMS. AS A RESULT THE VICTIM HAS RECIEVED SEVERAL HUNDRED MESSAGES ACROSS VARYING SOCIAL MEDIA FROM APPROXIMATELY 20 DIFFERENT PEOPLE. THE DEFENDANT HAS ALSO SENT THE VICTIM SEVERAL HARASSING MESSAGES AND THE SHEER VOLUME OF MESSAGES IS HARASSING AS WELL. THE DEFENDANT HAS ALSO THREATENED TO USE THE POLICE TO ARREST THE VICTIM AND HAS THREATENED TO SHOW UP UNINVITED TO THE VICTIMS LOCATION.
