He has called Child Protection Services on her and made fictitious complaints. He has also used the Brick Twp. Police department to harass her by calling the department and requesting that the department do welfare checks. The Brick Twp. Police Department has received 5 calls from Mr. Hone since 12/24/15 in refernce to [REDACTED] (12/24/15 C#76914-15, 1/27/15 C#5612-16, 1/30/16 C#6234-16, 2/4/16 C#7249-16 and 7275-16) in which all had no merit. On 1/28/16 Mr. Hone contacted victim via a phone call and stated "They told me to hire a private investigator, so I did. You're going to lose the kids" On 2/4/15 Mr. Hone contacted the victim via e-mail and within the he mentions using claymore mine. The continuing and repeating harassment and threats has made the victim fear for her life if Mr. Hone ever returns to New Jersey and has put her into emotional stress that she now needs counseling.

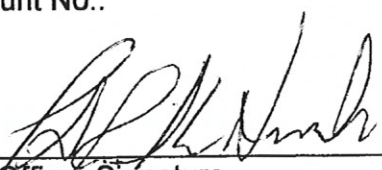

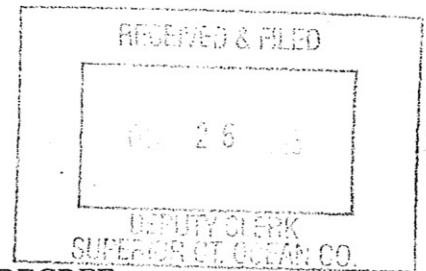

TERRORISTIC THREAT-THIRD DEGREE



The Grand Jurors of the State of New Jersey, in and for the County of Ocean, upon their oaths present that RICHARD HONE, between the dates of February 6, 2016 and February 9, 2016, in the Township of Brick, County of Ocean, and within the jurisdiction of this Court, with purpose to terrorize [REDACTED] or in reckless disregard of the risk of causing such terror, did threaten to commit a crime of violence, contrary to the provisions of N.J.S.A. 2C:12-3a, and against the peace of this State, the Government and dignity of the same.

COUNT TWO

STALKING-THIRD DEGREE

The Grand Jurors of the State of New Jersey, in and for the County of Ocean, upon their oaths present that RICHARD HONE, between the dates of February 6, 2016 and February 9, 2016, in the Township of Brick, County of Ocean, and within the jurisdiction of this Court, did purposely or knowingly engage in a course of conduct directed at [REDACTED]

██████ that would cause a reasonable person to fear for her safety or the safety of a third person or suffer other emotional distress, in violation of an existing Court Order prohibiting the behavior, specifically by calling and leaving threatening voicemails for ██████ ██████ in violation of existing Restraining Order FV-15-001113-15, contrary to the provisions of N.J.S.A. 2C:12-10c, and against the peace of this State, the Government and dignity of the same.

CONTEMPT-FOURTH DEGREE
