Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

Defendant and co-defendant entered United Check Cashing and claimed to be employees of SVS Associates Inc. in Wilkes Barre PA who were in the area performing insurance presentations. Defendant presented a check alleged to be from the same company with an issue date of 2021-07-16 issued to himself in the amount of \$6478.21. Defendant further provided a phone number for Ann T. Schatzel who allegedly signed the bottom of the check, and advised she was head of the company and could verify the check. Using the number provided, an employee called the number and spoke with a female claiming to be Ann Schatzel who assured the check was valid and authorized to be cashed. As a result the check was cashed. Co-Defendant also presented a check from the same business issued to her with an issue date of 6/26/2021 in the amount of \$1323.00 which was also cashed. Defendant and co-defendant both provided PA driver licenses issued in their name with their photographs to confirm their identity. On 07/26/2021 the manager of United Check Cashing learned from their bank the two checks were returned due to the accounts linked to said checks being previously closed. The business provided in-store images of defendant and co-defendant, as well as images of their PA driver licenses used to identify them. The in-store images were a match to the images on the driver licenses.

On 09/01/2021 this officer spoke with manager Steve Shultz of United Check Cashing in Harrisburg PA who confirmed defendant arrived at his business on 06/02/2021 and cashed a check from the same business in the amount of \$3713.88. Shultz also learned after the fact the account linked to the check was closed, and subsequently filed a police report with Swarta Police Department in PA. Shultz provided a customer identification report containing an in-store image of defendant and a copy of his PA driver license. Both images were a match to the images from United Check Cashing in Brick. Shultz also advised they too called Ann Ann T. Schatzel utilizing the same phone number who verified the checks.

Swarta Police Department was contacted and provided investigative reports showing after the incident was reported, Ofc. Gonzalez made contact with Ann Schatzel who confirmed SVS Associates Inc. had been closed for several years and she never authorized or signed any recent checks from the company.
