Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

The victim reported that an unknown male entered onto his property on 12/18/2021 in a silver colored pickup truck and removed his Steven Green flat trailer after loading a number of new extruded aluminum sections onto the trailer which are used for constructing boat lifts. Exterior surveillance cameras captured the theft. The truck in the footage appeared to be a silver colored four door GMC or Chevrolet with black rims, dark colored molding stripes on the lower portion of front and rear passenger doors, and foot bars across the bottom. An unknown white male wearing a hooded sweatshirt, ball cap, and jeans can also be seen as the actor, and had what appeared to be white paint on his shirt and pants, and also on the brim of his ball cap. The footage also showed what appeared to be a medium sized pit bull with floppy ears in the front passenger seat of the truck.

The victim created a public Facebook post containing several images of the suspect vehicle and suspect, and a narrative describing the theft requesting anyone with information contact them. On 12/22/2021 a witness who is owner of a bulkhead company contacted the victim on 12/25/2021 after seeing the Facebook post and advised he received a call from an unknown subject on 12/22/2021 trying to sell him boat lift parts. The subject advised the witness he had a full trailer load of new aluminum lift material for sale. When the witness told the subject he could not use the material, and advised he should contact Extreme Marine in Brick for the sale, the subject changed his tone and said the material was mostly junk and disconnected. The phone number used to contact the witness was provided to the victim, and also to this officer at a later date. On 12/29/2021 victim was contacted by an anonymous subject who observed the Facebook post and advised the subject in the images was defendant. The anonymous source provided defendant's Facebook profile showing images of defendant, what appeared to be the suspect pickup truck, and defendant's dog. The truck and dog matched the description of the truck and dog in the surveillance footage.

In-house records of defendant were searched and several were located. Most recently was a motor vehicle stop of defendant by Ptl. Sullivan on 10/21/2021 at 2252hrs. A review of Ptl. Sullivan's body camera footage revealed defendant was operating a 2010 four door silver GMC Canyon pick-up with matching foot bars, rims, and black molding stripes on the doors.

He was also wearing a ball cap with similar colored brim that also had white paint marks consistent with the brim of the hat the suspect in the surveillance footage was wearing. Defendant matched the physical description of the suspect in the footage. The truck was registered to Bernadett Baker of 48 Villanova Drive in Jackson NJ. A grand jury subpoena was served to Verizon Wireless for subscriber information of the cellular device and phone number utilized to call the witness on 12/22/2021. Verizon records revealed the registered subscriber of the phone was Bernadett Baker of 48 Villanova Drive in Jackson NJ.
