Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On Tuesday, January 4 2022, at approximately 0242 hours, I, Patrolman Murphy # 322 was dispatched to the area of 504 Linda Court for a possible fight. I was advised by dispatch while en route that the caller stated she heard a male screaming "I'm going to fuck you up!". The caller additionally advised she only saw one male at the time but was concerned a fight was about to happen. While en route I was advised of additional calls from the area of a male running between bushes and apartments.

Upon arrival to the area of Ivanna Lane and North Loop Road I observed a male who was pantless run from the area of Rena Court between the apartment buildings to the porch of 538 Linda Court. The male began banging on the door then slumped over at the waist and fell into a bush on the side of the porch. I called for EMS due to his apparent level of intoxication as precaution. I exited my marked patrol vehicle to check on the welfare of the male who I believed to be highly intoxicated. The male then got up and began screaming incoherently. I attempted to speak with the male but he charged at me then swung his right hand with a closed fist towards me striking me in the upper left shoulder. I called for additional units to respond. In attempted to created distance between the male and myself but due to icy conditions I slipped backwards onto the ground. The male continued approaching me as I was able to regain my footing. I then wrapped my arms around the male to control his arms, and he continued screaming incoherently. I again attempted to speak with the male as I controlled his arms but he was noncompliant with any commands or questioning.

I walked the male towards a nearby vehicle to utilize in getting the male into protective custody. The male was again noncompliant with any commands. The male then dropped his weight, tensing his legs. I felt the male may attempt to break free from my grasp at this point, so I was able to use my one leg to position in front of his, turning my body into his, and was able to control the male to the ground where I was able to eventually roll him to his back and place him into handcuffs for his and my safety. He was subsequently transported the hospital for medical attention and charged with the aggravated assault at a later date (01/11/22).
