THE DEFENDANT WAS OBSERVED ON SURVEILLANCE VIDEO ENTERING A Black Infiniti G35 NJ Reg [REDACTED] IN THE PARKING LOT OF WHITE CASTLE. THE DEFENDANT REMOVED A BROWN WALLET CONTAINING AN INVESTORS BANK DEBIT CARD, \$200.00 IN U.S. CURRENCY, AND A NJ LICENSE BELONGING TO D.R. THE DEFENDANT WAS THEN OBSERVED ON EXXON (600 BRICK BLVD) SURVEILLANCE VIDEO COMPLETING A PURCHASE OF CIGARETTES WITH THE VICTIM DEBIT CARD IN THE AMOUNT OF \$107.69. THE DEFENDANT THEN LEFT THE STORE AND WAS OBSERVED ON WAWA SURVEILLANCE ENTERING AND THEN LEAVING THE STORE.
