Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On 01/26/2022 Brick Township Police patrol officers took a harassment report from victim R [REDACTED] K [REDACTED] K [REDACTED] explained she was a Psychologist and has received multiple emails, calls, and texts from an ex-patient Bartholomew Forte for the past 2 years. She stated the content of the emails and texts have been vague and non-threatening, but feels they are becoming more erratic and that he is now using different aliases to contact her. K [REDACTED] stated she has not treated Forte in over 2 years due to allegation of misconduct reported by Forte to the State Board of Psychological Examiners.

On 01/24/2022 K [REDACTED] received an email from Forte saying "I hear you met my friend Paul from Resorts". K [REDACTED] stated that worried her, because she had just been in Atlantic City with a male acquaintance who worked at Resorts Casino. K [REDACTED] stated she felt as though Forte had been tracking her.

K [REDACTED] brought her vehicle (NJ Registration [REDACTED]) to a mechanic to have it inspected for any devices. While checking the vehicle a tracking device was found underneath the center. K [REDACTED] stated she had no idea how long that device had been attached to her vehicle. The device was magnetic and fixed to the vehicle. The device was made by TRACKi and had no serial number attached.

On 02/04/2022 I contacted TRACKi via email. I explained to them that I did not have a serial number for the device, but provided them with several of the suspects' emails used and phone numbers to check possible accounts. The representative from TRACKi, Tom Dillon advised that there were 5 devices associated with the suspect and that I would need a subpoena to receive the information. Dillon noted the customer requested the first 3 devices to be wiped on 02/04/2022.

On 02/08/2022 I sent the subpoena to TRACKi and received the information back on 02/11/2022. Dillon explained that the customer called on 02/07/2022 and had the devices transferred from one email account to another, then on 02/08/2022 he called them back and asked to unlink the devices from the new email. The customer was Forte with the known phone number and address associated with him, for all 5 devices.
