Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

ON 01/13/2022 AT APPROXIMATELY 2021 HOURS, I RESPONDED TO 2770 HOOPER AVE FOR A MOTOR VEHICLE ACCIDENT. UPON ARRIVAL I SPOKE WITH THE SUSPECT, MARGARET RODEO. WHILE SPEAKING WITH HER, HER SPEECH WAS SLOW, SLURRED, AND SHE WAS SPEAKING VERY SOFTLY. RODEO DID NOT HAVE ANY RECOLLECTION OF WHAT OCCURRED AND COULD NOT TELL ME WHICH DIRECTION SHE WAS TRAVELING BEFORE THE CRASH. WHILE SHE WAS PROVIDING HER DOCUMENTATION HER MOVEMENTS WERE EXTREMELY SLOW AND SHE FUMBLED THROUGH HER DOCUMENTS. I ALSO OBSERVED RODEO'S EYE LIDS TO BE DROOPY AND HER EYES BEGAN ROLLING INTO THE BACK OF HER HEAD AS IF SHE WAS FALLING ASLEEP. WHILE EXITING THE CAR, RODEO WAS UNABLE TO WALK OR STAND ON HER OWN. BASED UPON MY OBSERVATIONS AND THE CIRCUMSTANCES OF THE CRASH, RODEO WAS PLACED UNDER ARREST FOR DRIVING WHILE INTOXICATED, 39:4-50. THE DRIVER OF THE VICTIM VEHICLE (SD) SUSTAINED AN INJURY IN THE CRASH, SPECIFICALLY A COMPLAINT OF PAIN TO HER HEAD. DUE TO THE VICTIM'S INJURY, RODEO WAS CHARGED WITH ASSAULT BY AUTO, 2C:12-1C(2).
