MURDER

FIRST DEGREE CRIME

The Grand Jurors of the State of New Jersey, for the County of Monmouth, upon their oaths present that RONALD TESCHNER, on or about September 12, 2019, in or about the Township of Ocean, County of Monmouth, and within the jurisdiction of this Court, did commit the crime of Murder, by purposely or knowingly causing the death of J.T., or by purposely or knowingly causing serious bodily injury resulting in the death of J.T., contrary to the provisions of N.J.S.A. 2C:11-3a(1) and/or N.J.S.A. 2C:11-3a(2), and against the peace of this State, the Government, and dignity of the same.

SECOND COUNT

FELONY MURDER

FIRST DEGREE CRIME

The Grand Jurors of the State of New Jersey, for the County of Monmouth, upon their oaths present that RONALD TESCHNER, on or about September 12, 2019, in or about the Township of Ocean, County of Monmouth, and within the jurisdiction of this Court, did commit the crime of Felony

Murder by causing the death of J.T., while said RONALD TESCHNER, was engaged in the commission of, and/or an attempt to commit, and/or, flight after committing or attempting to commit the crime of Robbery and/or Arson and/or Burglary, contrary to the provisions of N.J.S.A. 2C:11-3a(3), and against the peace of this State, the Government, and dignity of the same.

THIRD COUNT

ROBBERY

FIRST DEGREE CRIME

The Grand Jurors of the State of New Jersey, for the County of Monmouth, upon their oaths present that RONALD TESCHNER, on or about September 12, 2019, in or about the Township of Ocean, County of Monmouth, and within the jurisdiction of this Court, did commit the crime of Robbery, by, while in the course of committing a Theft, inflicting bodily injury or using force upon J.T., and/or committed or threatened to commit any crime of the first or second degree, and that in the course of committing said crime the RONALD TESCHNER attempted to kill J.T. and/or purposely inflicted or attempted to inflict serious bodily injury on J.T., contrary to the provisions of N.J.S.A. 2C:15-1, and against the peace of this State, the Government, and dignity of the same.

FOURTH COUNT

BURGLARY

SECOND DEGREE CRIME

The Grand Jurors of the State of New Jersey, for the County of Monmouth, upon their oaths present that RONALD TESCHNER, on or about September 12, 2019, in or about the

Township of Ocean, County of Monmouth, and within the jurisdiction of this Court, did commit the crime of Burglary, by unlawfully entering a structure, to wit: 2019 Jeep Cherokee, motor vehicle, belonging to J.T., or a separately secured or occupied portion thereof, which was not at the time open to the public, without being licensed or privileged to enter, with the purpose to commit an offense therein, and in the course of committing said crime, RONALD TESCHNER purposely, knowingly, or recklessly inflicted, attempted to inflict, or threatened to inflict bodily injury on J.T., contrary to the provisions of N.J.S.A. 2C:18-2, and against the peace of this State, the Government, and dignity of the same.

FIFTH COUNT

AGGRAVATED ARSON

SECOND DEGREE CRIME

The Grand Jurors of the State of New Jersey, for the County of Monmouth, upon their oaths present that RONALD TESCHNER, on or about September 12, 2019, in or about the Township of Ocean, County of Monmouth, and within the jurisdiction of this Court, did commit the crime of Aggravated Arson by, starting a fire with the purpose of destroying a building or structure of another, to wit: 86 Wickapecko Drive, Ocean Township, New Jersey, belonging to J.T. and/or Wapac L.L.C. and/or D.A and/or M.Z., contrary to the provisions of N.J.S.A. 2C:17-1a, and against the peace of this State, the Government, and dignity of the same.

SIXTH COUNT
AGGRAVATED ASSAULT
THIRD DEGREE CRIME

The Grand Jurors of the State of New Jersey, for the County of Monmouth, upon their oaths present that RONALD TESCHNER, on or about September 12, 2019, in or about the Township of Ocean, in the County of Monmouth, and within the jurisdiction of this Court, did commit the crime of Aggravated Assault, by knowingly or purposely starting a fire or causing an explosion, in violation of N.J.S.A. 2C:17-1, which resulted in bodily injury to M.W. and/or J.B., emergency service personal involved in the fire suppression actives and/or rendering emergency medical services resulting from the fire or explosion and/or rescue operations, and/or rendering any necessary assistance at the scene of the fire or explosion, including all bodily injury sustained while responding to the scene of the reported fire or explosion, contrary to the provisions of N.J.S.A. 2C:12-1(b)(8), and against the peace of this State, the Government, and dignity of the same.
