On 03/29/2022 at approximately 1905 hours, acting Sgt. Alexander #217, Ptl. Haugh #217, and I responded to Target in reference to a shoplifting. While at the business, loss prevention advised the defendant had failed to scan 7 items at the self-checkout lane totaling \$143.60. The defendant then proceeded passed all points of sale when approached by loss prevention. The defendant was read her Miranda warning and asked what had occurred and stated she did not realize the items in question had not scanned. It should be noted on scene establishment staff advised the defendant was observed on video surveillance on 03/27/2022 conducting a similar act removing 12 unpaid miscellaneous items totaling \$259.58 from the establishment.
