1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

The defendant and co-defendant were observed by a resident at 280 18th Avenue (Brick, NJ) operating a black Mercedes Benz bearing PA registration [REDACTED] between the hours of 0800-0900 on 04/27/2022. At 1306 hours, patrol responded to 240 18th Avenue for an attempted burglary to the residence. The caller reported two (2) black males operating a dark colored Mercedes just left headed toward River Rock. The males partially gained entry to a rear garage window after breaking it. The defendant fled the scene after hearing barking dogs. A description was broadcasted to responding patrol units who located a vehicle and two (2) suspects matching the description in front of River Rock Liquor Store. Ptl. Newlund approached both males who fled on foot. Ptl. Newlund pursued the defendant who was ultimately taken into custody in the parking lot of Crystal Point. After Ptl. Newlund gave chase to the defendant, the co-defendant is observed on surveillance video returning to the passenger door, removing a handgun and throwing it on the side of the building. The co-co-defendant then climbed the roof of the liquor store and was later located on the Brielle Bridge where he was placed into custody. The handgun was located and recovered. The handgun was found to contain ten (10) 9mm cartridges, one being a hollow point round. The handgun was also inspected and found to be loaded with a fifteen (15) round magazine.
