Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:
On 06/05/2022 I responded to [REDACTED] and spoke with the caller/victim, [REDACTED]. She advised that approximately two years ago she was in an intimate relationship with the defendant, Jason Lanier. After their physical relationship ended they stayed in contact. On 06/03/2022 Lanier arrived unannounced at her residence while she was in the shower. Lanier entered through an unlocked front door even though he had no permission to do so. Once inside he confronted her in the bathroom about the possibility of her having a new boyfriend. After a period of time Lanier exited the residence. On 06/04/2022 [REDACTED] received multiple messages from friends that flyers with her picture on them had been distributed throughout Freehold. The flyers contained a photograph of [REDACTED], as well as hand written messages that were derogatory in nature. One message read "summer where she is for the streets she sucks and fucks for nothin, her man in jail so she is free. call or text" while listing her phone number. Some of the photos on the flyers were photocopies of [REDACTED] in various states of undress, including some where her intimate parts were visible. She recognized that the photographs were copies of pictures that she had kept in her bedroom drawer. When she checked for them she realized that they had been stolen and believed Lanier must have taken them while he was in the residence on 06/03/2022. On 06/05/2022 she continued to receive messages from friends stating there were additional flyers posted around the town. At this time she contacted the police. I was able to make contact with Lanier over the phone who admitted to posting some of the flyers but not any of the flyers that showed [REDACTED] intimate parts.
