Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

The defendant was observed on surveillance video entering the establishment at 0434 hours. The defendant threw a rock through a glass door to gain entry into the establishment. Once inside, the defendant proceeded to the cash register after attempting to open it. While doing so, the defendant caused damage to the register and removed approx. \$100.00 in change. The defendant entered the kitchen area and fled the scene.

During the course of the investigation, several other locations in Brick Township and the Ocean/Monmouth County were investigating similar "Smash and Grab" type burglaries to commercial businesses. Wall Township PD developed information on a suspect identified as the defendant. Wall Township PD applied for and was granted a Communications Data Warrant (CDW) for the defendant's cellular device. Upon examining the CDW Wall Township provided a copy to this agency which detailed the defendant's location was active in the area of three (3) separate smash and grab burglaries in Brick Township. This affiant applied for a CDW through the Ocean County Superior Court which was granted and results obtained from T-Mobile. With the assistance of the New Jersey State Police Cellular Assistance Team the, defendant's cellular device was identified and active in the area of the burglaries in Brick Township. Furthermore, the surveillance video obtained from Jovo's and suspect observed matched the physical characteristics of the defendant.

The defendant was observed on surveillance video entering the establishment at 0745 hours. The defendant threw a rock through a side glass window to gain entry into the establishment causing \$300.00 in damage. Once inside, the defendant proceeded to main desk where the cash register was located. Nothing was removed. The defendant was seen leaving the area.

During the course of the investigation, several other locations in Brick Township and the Ocean/Monmouth County were investigating similar "Smash and Grab" type burglaries to commercial businesses.
