Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On June 24th, 2022 at approximately 1659 hours, Ptl. Farnkopf #314 and I (Ptl. Lanni #307) responded to the Stop N Shop (55 Brick Boulevard) in reference to a shoplifting. Dispatch stated asset protection has a female subject in their office who shoplifted over \$200.00 worth of merchandise.

Upon our arrival, I met with asset protection associate and witness V.S.. V.S. stated they have an adult female subject, later identified as the defendant G.W., in their office that they caught attempting to shoplift merchandise from the store. V.S. explained she first observed G.S. via security cameras in the store placing multiple items into reusable grocery bags. V.S. said this caught her attention as it is a common shoplifting tactic to place unpaid goods in bags in an attempt to conceal them. V.S. went on to state she observed G.W. continue to go throughout the store and continue to place items into the reusable bags. V.S. also said she observed G.W. place lowered price stickers over two bakery items in an attempt to alter the sale price. V.S. stated G.W. then approached to the self-check out register twice, paid for a few select items in two separate payments, and then exit the store. V.S. said G.W. was stopped outside the doors after she bypassed all other points of payment. V.S. also stated G.W. has been cooperative and admitted to her shoplifting.

I observed the security footage in question which shows G.W. place multiple grocery store items into reusable bags, affix labels to grocery store items in an attempt to purchase them at a lower cost, approach the self-check out registers to pay for a few select items, and proceed to exit the store.

I met with G.W. in the asset protection office. I advised G.W. of her Miranda Rights to which she said she understood and would speak with me. G.W. stated she "stole" items from the store and did not speak further on the incident.
