Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On 07/12/2022 at approximately 1619 hours, patrol units responded to [REDACTED] in reference to a burglary. Inside the residence, the victim's room was ransacked and his television and door were both broken. The majority of the cabinets had been emptied and the room was in total disarray. The victim stated that Jessica Pescatore was the one who had burglarized his house as she is his ex-girlfriend and had texted him several times earlier in the day that she was coming to his house. Pescatore texted the victim that she was going to beat him and his mom up and called him several times in a harassing manner. The victim stated that his phone and charger had been stolen from the house and that the incident had to occur between 0700 and 1600 hours that day. Point Pleasant Borough Police Department advised that Jessica Pescatore was in their custody after an incident of domestic violence in their town. She had on her person a black Samsung phone and pink charger that she advised PBPD was her ex-boyfriends. Additionally, she stated to PBPD officers that prior to her incident in Point Pleasant she was coming from her ex-boyfriend's home in Brick. PBPD advised that Pescatore was wearing a yellow shirt when they encountered her and she had changed her pants as they had blood on them. Video footage was obtained from the neighbor's house at [REDACTED] which showed a female subject matching Pescatore's description exit a dark gray SUV wearing a yellow shirt enter the residence at 1430 hours. This was 30 minutes after Pescatore texted the victim that she was on her way to his house. Pescatore was subsequently arrested for burglary, criminal mischief, theft, and harassment.
