Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:
On 07/09/2022 at 1845 hours I responded to Walmart (1872 Rt. 88) for a report of two females shoplifting. Walmart Loss Prevention advised that two black females left the store without paying for all of their items. After leaving the store the two females pushed two shopping carts out of the store and were attempting to leave the parking lot. After being confronted by loss prevention they left one of the shopping carts and continued to the intersection of Rt. 88 and Jack Martin Blvd. Ptl. Joaquim was able to locate the first suspect LW standing on the side of the road. Ptl. Joaquim advised me that the second suspect DC was across the street. While speaking with DC she stated that she had the receipt for all of the items in her shopping cart. I was able to look at the receipt and the items in the cart which did not match up. DC also had other bags in the cart which had items that appeared to have been shoplifted from Walmart. Loss Prevention was able to look through the receipt and determine which items were stolen and which items were paid for. LW was also placed under arrest because the shopping cart that she had been pushing also had items that had been stolen. Loss prevention went through LW's cart and identified the items that were purchased and what items were stolen. Loss Prevention stated that the total of the stolen merchandise was \$920.40.
