Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:
On 7/30/22 (C# 53082-22) and on 7/31/22 (53462-22), it was reported to the Brick Township Police Department that items of jewelry and collectible coins were stolen from 293 Cherry Quay Road and 1238 Concord Drive. The victim had then discovered and recovered some of the missing items from her daughters boyfriend's (Jarrett Sansone) vehicle, which was parked on her property for several months and not operable. Further investigation revealed that Jarrett Sansone had RAPID second-hand dealer transactions at multiple stores throughout the townships of Brick and Toms River during the months of June and July in 2022. I, Det. Farnkopf #230, then confirmed with the stores that Sansone had sold the stolen items to them, and recovered what items the stores still had in their possession.

Further investigation revealed that Jarrett Sansone had RAPID second-hand dealer transactions at multiple stores throughout the townships of Brick and Toms River during the months of June and July in 2022. Det. Farnkopf #230, then confirmed with the stores that Sansone had sold the stolen items to them, and recovered what items the stores still had in their possession. A search warrant of Sansone's vehicle also revealed 22 Win mag ammunition that was stolen from 1238 Concord Drive.
