Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On 09/05/2022 officers responded to 69 River Park Drive in reference to an active fight. The victim advised that his brother, Shane Panuska, was breaking things inside of the residence and then began fighting him. The victim stated that Panuska had punched ten holes in the wall and had thrown his shoe at the television, breaking it. After this, Panuska began fighting with him and punched him in the face with a closed fist. This caused redness on the left side of the victim's face. The victim stated that the incident began after his father had misplaced the remote for the television, prompting Panuska to turn violent. Panuska was mirandized and admitted to punching the holes in the wall and throwing the shoe at the television. He stated that he was fighting with the victim but did not punch him in the face. Panuska stated that he was not the aggressor in the incident and stated that his brother and father had instigated it. I observed the property damage inside the residence and the injury on the victim's face. Both the victim's mother and father were involved in the incident and corroborated the victim's testimony.
