Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:
THE VICTIM ALLOWED THE DEFENDANT TO DO LAUNDRY AND OTHER ACTIVIES AT THE VICTIM'S RESIDENCE THE DAY PRIOR TO THE INCIDENT. THE VICTIM ALLOWED THE DEFENDANT TO STAY THE NIGHT AND ALSO SPENT THE FOLLOWING DAY AT THE VICTIM'S RESIDENCE IN A SPARE BEDROOM. PRIOR TO CALLING THE POLICE, THE VICTIM WOKE UP TO THE DEFENDANT OUTSIDE HER RESIDENCE REMOVING BAGS OF ITEMS FROM INSIDE THE RESIDENCE. THE VICTIM WAS ABLE TO LOOK INSIDE ONE OF THE BAGS AND OBSERVED MULTIPLE ITEMS THAT BELONGED TO HER THAT WERE TAKEN FROM THE HOUSEHOLD. IT WAS LATER DETERMINED THE DEFENDANT HAD PLACED NUMEROUS RANDOM ITEMS FROM INSIDE THE RESIDENCE INSIDE HER BAGS THAT DID NOT BELONG TO HER AND SHE ALSO TOOK ITEMS FROM ROOMS INSIDE THE RESIDENCE THAT SHE WAS NOT GIVEN PERMISSON TO ENTER. THE DEFENDANT WAS INTENDING ON LEAVING THE RESIDENCE WITH THE ITEMS INSIDE HER BAGS.

Affidavit of Probable Cause

5. On 11/25/2022 at 2145 hours, Brick Township Police Department patrol units responded to 42 Rialto Drive in reference to a domestic violence incident. During the initial response, dispatch was advised by the caller, a male subject was in possession of a firearm and "fired it in the house". The defendant was heard yelling on the phone during the initial 9-1-1 call. A.M was identified as the mother was the caller who reported Christopher was out of control. Patrol units responded to 42 Rialto Drive and established a perimeter due to the involvement of a weapon. The Brick Township Police Dept Special Emergency Response Team (SERT) was also dispatched and responded. The defendant exited the residence and was taken into custody after physically fighting with law enforcement. During the investigation, it was learned the defendant pointed a firearm at the victim [REDACTED] making verbal threats to kill her and family. Prior to the pointing of a firearm, the defendant discharged one (1) round from a firearm inside the residence. To locate the firearm, a court authorized search warrant was obtained for the residence.
