Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On 10/01/2022 at approximately 2251 hours, Police units responded to 300 Hulse Avenue in reference to a 9-1-1 hang up in which the victim could be heard yelling into the phone by dispatchers. Upon arrival, the female was found in the driveway by Police holding a bloody rag to her head. The victim stated she was involved in an altercation with her boyfriend, the defendant in this matter. The victim initially stated she fell to the ground while arguing with the defendant in the driveway, where she struck her head on the concrete driveway causing her to lose consciousness and a laceration on her forehead. In addition, the victim had a swelling to her cheek bone below her right eye socket. The victim's juvenile daughter was on scene and stated she observed the defendant standing over the victim in the driveway pulling her wig off her head while yelling at her. The victim later stated that her boyfriend, the defendant, pushed her to the ground during the altercation and pulled her hair from behind while she was on the ground stating, "See you shouldn't have done this." The defendant fled the area on foot according to the victim and the daughter and could not be located by patrols. The victim was transported to Ocean Medical Center due to her injuries. Both the victim and the defendant have prior domestic violence history at this residence.
