Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:
On 10-5-2022 at approximately 2320 hours Ptl. Noorman-Hilling #319, Ptl. Dudak #313, Ptl. Patrick #296 and I, where dispatched to 63 Channel Drive for a welfare check on the son of the caller. Upon arrival, we met with the victim, who had visible signs of injury to her upper lip. Victim stated she was struck in the face with a piece of glass that was thrown in her direction by the defendant while he was damaging her property. Upon entering the house, we talked to the victim's husband, who showed us broken glass on the living room floor that appeared to come from a glass bottle. Victim's husband reported the same story as victim. Victim's bedroom was located upstairs, and upon entering the room officers observed damage to many items belonging to victim (dresser, mirror, picture frame, and wall). Defendant was located asleep on victim's bed. After awaking defendant, he denied the victim's report and refused to answer any questions. While speaking with defendant, officers observed small lacerations on his knuckles, indicative of him punching/destroying glass objects and walls.
