The defendant proceeded to approach the victim again, at this point the victim proceeded to strike the defendant with his right fist causing a laceration to the defendant's left eyebrow. The victim proceeded to go grab some clothes and leave the scene of the incident in a black Subaru where he was later pulled over in a motor vehicle stop.
