On May 17th, 2020 at approximately 1144 hours, the Brick Township Police Department received a 9-1-1 call from a Michael Stallworth, advising that a female located at 28 Creek Road in Brick, NJ was unresponsive. Police responded and found a female, later identified as Rebeca Gavilanez Alectus, laying in the upstairs bedroom on the "one side" of the residence. The female was not breathing, and significant trauma could be seen to the left side of her head and a large quantity of blood on the bed and walls. A cylindrical container was observed near the body, covered in blood. The victim was pronounced deceased at 1614 hours by Dr. Poco of JFK Hospital through medic unit 2493.
2. It was learned through field interviews that the victim was in a relationship with a Mayra Gavilanez Alectus, and that the two have been involved in verbal altercations while they were in Ecuador in the recent weeks. Both the decedent and Mayra were known to reside together at 28 Creek Road in Brick, NJ.
3. Based on the previous information, telephonic search warrants were sought and granted by the Honorable Michael T. Collins, Judge of the Superior Court of Ocean County. The warrants obtained were for the search of the residence, 28 Creek Road in Brick, NJ, common area including two sets of dumpsters located in the community, and for the real time GPS location and historical location data for the cellular phone belonging to Mayra Gavilanez Alectus, specifically T-Mobile telephone facility number [REDACTED]
4. The physical location information for telephone facility number [REDACTED] was returned from T-Mobile support and showed that the cellular phone was not currently powered on. The search showed that that number, believed to belong to

Mayra Gavilanez Alectus, made several calls on May 16th and May 17th. One number that was called was determined to belong to a travel agent.

5. The New Jersey Motor Vehicle Commission database was used to obtain pedigree information and a photograph of Myra J. Gavilanez-Alectus. NJ Motor Vehicle Commission also showed that Myra Gavilanez-Alectus operated a 2005 Red Chrysler Pacifica bearing NJ registration [REDACTED]
6. On May 17, 2020, Det. Steinberg and Det. Carroll obtained a digitally recorded statement from an OD'Amuo Alectus at the Brick Township Police Department. In brief, OD' Amuo advised that he is the brother to the decedent. OD'Amuo advised he received a telephone call in the morning hours on May 17, 2020 from his mother, Mezanie, in reference to her not being able to get in contact with the decedent. OD'Amuo advised that he then attempted to contact the decedent via telephone and was unable to make contact. OD'Amuo stated he then called Francia Villacis-Gavilanez, the daughter to Mayra Gavilanez, in attempt to make contact with the decedent. After doing so, OD'Amuno responded to the decedent's residence at 28 Creek Road. Upon arrival, he observed the Brick Township Police Department at the said residence, wherein he then learned the decedent was deceased.
7. On May 17, 2020, Det. Steinberg and Det. Carroll obtained a digitally recorded statement from Francia Villacis-Gavilanez at the Brick Township Police Department. In brief, Francia advised she received a telephone call from OD'Amuo stating they could not get in contact with the decedent. Francia then attempted to contact her mother, Mayra, via call and text messaging. Francia advised she was unable to make contact and decided to respond to the residence at 28 Creek Road. Francia was accompanied by her boyfriend, Michael Stallworth. Upon arrival, Francia stated they knocked on the front and back doors and received no answer. They observed the front window to be open. Stallworth made entry into the residence by removing the screen and climbing through the opening. He unlocked the

front door and let Francia inside the residence. They walked upstairs to the second floor and observed a female laying in the bed of the master bedroom. They observed what appeared to be blood everywhere in the bedroom. They then called 911 from Stallworth's cellular telephone number [REDACTED]

8. Francia further stated that she and her mother, the suspect, have joint bank accounts. The TD bank information for the accounts was provided to police. Francia further advised that Mayra is married to the decedent and they returned from Ecuador at the end of February. Francia stated that they have only been residing at the residence for approximately one month. Francia advised she last spoke with Mayra on May 16, 2020 via telephone between 1500 hours and 1700 hours. Francia stated Mayra told her she was at the store getting food for the kids. Francia asked Mayra about the decedent, when Mayra told her the decedent was home sleeping. Francia advised she has had no additional contact with the Mayra. Francia stated she has attempted to contact Mayra via telephone and text messaging with no response. Francia advised when she attempts to call, it was going right to voicemail.
9. On May 17, 2020, Det. Steinberg and Det. Carroll obtained a digitally recorded statement from a Michael Stallworth at the Brick Township Police Department. In brief, Michael stated Francia received a telephone call in the early morning hours on May 17, 2020, from OD'Amuo in reference to not being able to make contact with the decedent. At that time, Stallworth and Francia responded to 28 Creek Road to attempt to make contact with either the decedent or Mayra. Stallworth advised Francia also attempt to contact Mayra via telephone with negative results. Once at the residence, Stallworth advised they knocked on the front and back doors and received no answer. Stallworth then made entry to the residence through the front window. Stallworth stated he removed the screen, climbed through the window, and unlocked the front door to let Francia inside. They proceeded to walk upstairs and observed a female laying in the bed of the master bedroom covered in blood under a

sheet. They uncovered the victim, then called 911 and exited the residence.

10. On May 17, 2020, Det. Steinberg and Det. Carroll obtained a digitally recorded statement from a Leonard Villacis at the Brick Township Police Department. In brief, Leonard advised on May 17, 2020 he received a telephone call in the morning hours from his cousin, Christian Topana from Ecuador, stating there was someone dead at his mother's residence. Leonard then attempted to contact his mother, Mayra Gavilanez, but received no answer. Leonard then responded to said residence. Leonard stated he has not talked with his mother in a couple days. Leonard advised Mayra attempted to call him twice on May 17, 2020 between 1900 hours and 2000 hours. Leonard stated he was sleeping and did not see the missed calls until after midnight. Leonard further identified a photograph of his mother Mayra.
11. Leonard Villacis and Francina Villacis-Gavilanez consented to the search of their phones, which were conducted by Detective Mantle of Ocean County Prosecutors Office High Tech Crime Squad and returned to both parties.
12. On May 18, 2020, Detective Carroll and Detective Steinburg spoke with Mandy O'Shanghnessy, the Executive Director of the Chelsea assisted living in Toms River NJ. She stated that the decedent worked on Saturday, leaving at 1600 hours, and she failed to report to work on May 17, 2020. A coworker, Snyne Etienne, responded to the decedent's residence at Creek Road, knocked on the door, and received no answer. They then notified the mother of the decedent.
13. Detective Denis Mitchell of the Ocean County Prosecutor's Office was able to secure surveillance footage from 32 Creek Road, 1166 Sawmill Road, 1180 Sawmill Road, 1186 Sawmill, and footage from the Sawmill complex.

14. On 5/16/2020, Automatic License Plate Readers logged Mayra Gavilanez-Alectus's vehicle traveling north from the Brick area. The final log of the vehicle was recorded by NYPD on 05/16/2020 at 1911 at Canal and West Street.

15. On 05/17/20, a Grand Jury Subpoena Duces Tecum was issued to TD Bank requesting any and all accounts held by or for the benefit of Mayra Gavilanez. Detective Llauguet of the Ocean County Prosecutor's Office spoke with a representative from TD Bank regarding these accounts. It was discovered she had several accounts with TD Bank and had been a customer since 2009. There were several transactions pending to post to the account on 05/18/20. Those transactions included:

- Wawa
- Walmart
- Home Depot
- AutoZone
- McDonald's
- ATM withdrawal of \$700 at Popular Bank located at 285 Madison Avenue, New York, NY at 1931 hours on 05/16/20. The account number provided is [REDACTED]

The exact time and location of these transactions is pending until they are posted to the account.

16. On 05/18/2020 at approximately 1245 hours, Detective John Carroll received a phone call from Leonard Villacis, the son of Mayra Gavilanez Alectus, stating that he had just noticed that \$400.00 was just added to his TD bank account [REDACTED] by his mother ([REDACTED]) from days prior.

17. On 05/18/2020, Detective Lieutenant Carlos TrojilloTovar made contact with Lina Morricho, the owner of cellular telephone number [REDACTED] which was contacted by the number believed to belong to Mayra Gavilanez

Alecutson 05/16/2020 at 1835 hours and 1837 hours. Lina Morricho was found to work for a travel agency, Costa Mar. She advised that she never returned the phone calls.

18. On 05/18/2020 at 1100 hours, a post mortem examination was conducted on the body of the decedent Rebecca Gavilanez Alectus. The examination, which took place at Community Medical Center, was performed by Dr. Dante Ragasa from the Ocean County Medical Examiner's Office. Dr. Ragasa determined the cause of death of Rebecca Gavilanez Alectus to be **Blunt Force Injuries To The Head** and the manner of death to be **Homicide**.
19. On 05/18/2020, while processing the scene at 28 Creek Road in Brick Township NJ, Detective Lesniakowski of the Ocean County Sheriff's Department's CSI Unit located a fingerprint from the "one finger" specifically the right thumb, on the aforementioned cylindrical container, consistent with a wine chiller, found near the victim's body, which was covered with blood. The item is logged as Sheriff's Department evidence number 15. The fingerprint was analyzed by Fingerprint Examiner Caitlyn McQuade of the Ocean County Sheriff's Office and found to belong to Mayra Gavilanez Alectus. The fingerprint was made in comparison to an employment fingerprint card in the name Mayra Villacis, an alias listed for Mayra Gavilanez Alectus. The date of birth of 01/15/1972 and SSN: [REDACTED] also matched both the alias and the legal name.
20. Also recovered from the residence at 28 Creek Road were various passports and identification cards for Mayra Gavilanez Alectus showing the following names: Mayra J. Gavilanez Alectus, Mayra J. Villicis, Mayra Janeth Gavilanez-Verdezoto, Mayra Gavilanez Vargas-Mentor Anabel.
21. In addition to the above referenced items, the Ocean County Sheriff's Department also recovered the following items from the residence:

- k. Item 18- Apple Iphone A1687
- l. Item 19- Acer B1-720 Tablet
- m. Item 20- Apple Iwatch Carger
- n. Item 21 Amazon Firestick Model LY73PR

22. In addition, during the investigation various federal agencies including the Federal Bureau of Investigation, Department of Homeland Security and Immigrations and Customs Enforcement have assisted with adding alerts and travel restrictions under the name Mayra J. Gavilanez-Alectus and her aliases. Through field interviews it was learned that Mayra Gavilanez-Alectus was known to travel to Ecuador via JFK airport in New York.

23. On 5/18/2020 at approximately 1620 hours, Detectives Steinberg and Carroll conducted a taped statement with Snyrne Etienne, a coworker and close friend of the victim. Etienne stated that she worked with Rebeca and that Rebecca had been telling her that she no longer wanted to be in a relationship with Mayra. Mayra allegedly offered the victim \$3,000.00 to stay in the relationship with her. The victim told Etienne that she wanted to date a man, and no longer wanted to be in a same sex relationship. On Saturday, 05/16/2020, Mayra drove Rebeca to work, and picked her up at approximately 1500 hours. The vehicle description provided by Etienne was consistent with the Chrysler Pacifica operated by the suspect, Mayra Gacilanez-Alectus. Rebeca told Etienne that she was taking her wedding ring off, and did not plan to wear it anymore. Etienne told Rebecca to remove the children from the house, after Rebeca told her that she was becoming afraid of Myra. It was believed that Rebeca had dropped her children off at a family member's house on Friday May 15, 2020.

24. It was reported that at 1633 hours on May 16, 2020, Etienne sent a WhatsApp application message to the victim, which was not read or opened. That made her concerned, and she again called her at 2300 hours with negative contact. Etienne wasn't scheduled to work the following day with Rebeca, but she became concerned when she didn't hear from her friend. Etienne came to work at 0600 hours on Sunday to make sure that the victim was okay. She then called the

manager and went to Rebeca's grandmother's residence, and asked that they go to the residence to check on her. They arrived between 0800 and 0900 hours. The doors were locked and the car was missing. She then spoke to the neighbor at 26 Creek, who stated that the vehicle was not present after 1700 hours on 05/15/2020.

25. On 05/18/2020 at approximately 1430 hours, Senior Assistant Prosecutor Kristin Pressman reviewed the facts of the case. Subsequent to her review, charges were authorized for issuance of an arrest warrant for Mayra J. Gavilanez-Alectus for Murder, Possession of a Weapon for an Unlawful Purpose, and Unlawful Possession of a Weapon.

It is, therefore, on 01/12/2023 **ORDERED** and **ADJUDGED** that the defendant is sentenced as follows:
 With respect to the sentencing on Indictment No. 22-08-01446-I, Defendant was found guilty of Counts 1, 2 and 3 by a jury of her peers and is sentenced as follows:

Count 1 : Defendant is sentenced to 45 Years to the custody of the Commissioner of the Department of Corrections, subject to 30 Years of parole ineligibility, and with Credit for Time Served of 967 days. Pursuant to the No Early Release Act, the Defendant must serve 85% of the 15 Year term imposed after the 30 Years of parole ineligibility and because this matter is being sentenced as a first-degree offense, Defendant is subject to a five (5) year period of parole supervision upon release.

Count 2 : Merged into Count 1.

Count 3 : Merged into Count 1.

Defendant is hereby ordered to provide a DNA sample and ordered to pay the costs for the testing of the sample.

Defendant is assessed the fines, fees and penalties as set forth on page 2 hereof. The Court waives the \$7,500.00 restitution sought by the Victims of Crime Compensation Office (V.C.C.O.), based upon this Court's assessment of the Defendant's inability to pay. The remaining mandatory fines, fees and penalties are to be paid through the Department of Corrections.
