1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On 12/22/2022 at 1852 hours, I (Ptl. Tavalaiaccio #329) was dispatched to the parking lot of Lowes Home Improvement located at 520 Rt. 70 in reference to a suspicious condition involving a white Jeep Grand Cherokee with no license plates. Dispatch advised that a vehicle matching the same description was involved in a shoplifting incident at approximately 1500 hours. Upon arrival, I located the suspect vehicle in the parking lot which was occupied by the driver Michael Ritz and passenger Erin Royer. LaPoint #222 walked his K9 around the vehicle which had a positive indication for CDS. After searching the vehicle incident to arrest a needle containing an unknown substance was located between the driver seat and driver side door. In addition, various items from multiple stores in the area (Kohl's, Lowes, and Burlington Coat Factory) were located in the rear of the vehicle. Many of the items were high value items and had security devices attached to them. The value of all of the suspected stolen items inside of the vehicle is approximately \$3,364.05.

On 12/22/2022 at 1852 hours, I (Ptl. Tavalaiaccio #329) was dispatched to the parking lot of Lowes Home Improvement located at 520 Rt. 70 in reference to a suspicious condition involving a white Jeep Grand Cherokee with no license plates. Dispatch advised that a vehicle matching the same description was involved in a shoplifting incident at approximately 1500 hours. Upon arrival, I located the suspect vehicle in the parking lot which was occupied by the driver Michael Ritz and passenger Erin Royer. When speaking to Ritz, I observed security tags in plain view on packages and I could hear them beeping. In addition, a pair of cutting pliers was passenger seat of Ritz's vehicle. Ritz was asked to step out of his vehicle to which he complied. After reading Ritz his Miranda Rights, he advised me that he understood his rights and was willing to talk to me about the incident. Ritz stated he was with his friend and that they were going into Lowes to get screws to reattach his license plate to his vehicle. Ritz advised me of being previously arrested for CDS. Ptl. LaPoint #222 walked his K9 around the vehicle which had a positive indication for CDS. After searching the vehicle incident to arrest a needle containing an unknown substance was located between the driver seat and driver side door. In addition, various items from multiple stores in the area (Kohl's, Lowes, and Burlington Coat Factory) were located in the rear of the vehicle. Many of the items were high value items and had security devices attached to them. The value of all of the suspected stolen items inside of the vehicle is approximately \$3,364.05.
