On March 7th, 2023 at approximately 2238 hours, a 9-1-1 call was received by the Ocean County Sheriff's Office and transferred to the Lakewood Police Department (due to the broad location of the GPS for the device) from [REDACTED]. The caller was yelling for help before disconnecting. Upon callback, she was able to

provide her name and basic information before the connection was terminated.

The Patrol Division was able to ascertain the address of the caller (A [REDACTED] V [REDACTED]-A [REDACTED]) as 75 North Hope Chapel Road in Jackson Township. Patrol responded to that address and spoke to multiple residents and despite a language barrier (Spanish) were able to ascertain that V [REDACTED]-A [REDACTED] and her infant were taken against her will after the two had an altercation at the residence. They advised there was a history of domestic violence between the two. The boyfriend and father of the child involved in the matter was named as Gerson Aguilar-Lara. D/Sgt Melissa Rose of OCPO came and confirmed the aforementioned speaking to the witnesses in Spanish.

Based on the domestic violence history, the 9-1-1 call yelling for help, the information learned from the witnesses, and the fact that V [REDACTED]-A [REDACTED] was not answering family and friends attempts to reach her, the Watch Commander, Sergeant Keith Uricks contacted the Detective Bureau and Ocean County Prosecutor's Office Major Crime Unit and requested assistance. This Detective and Jackson Police Supervisors as well as Major Crime Detectives made the determination to put out county Stop and Holds on the vehicles and to utilize emergency locating technology to attempt to find the phones for Aguilar-Lara and

V[REDACTED]-A[REDACTED]. Results were obtained and Patrol and Detectives began to search the known areas.

Toms River Police Patrol located the suspect vehicle (Chevy Equinox TX- [REDACTED]) and followed the vehicle waiting for additional units. The vehicle pulled into a parking lot of Route 37 and came to a stop with the driver fleeing on foot. He was taken into custody by Toms River Police shortly after.

A[REDACTED] V[REDACTED]-A[REDACTED] and the juvenile were recovered uninjured and transported to Jackson Police so V[REDACTED] could give a formal statement. Upon arrival, she and her infant were escorted to the interview room where she provided a taped statement regarding the facts of the investigation. The interview, which was given in Spanish, was conducted by D/Sgt Melissa Rose of Ocean County Prosecutor's Office with this writer and Detective Brant Uricks present.

An abridged summary of the statement given by A[REDACTED] V[REDACTED]-A[REDACTED] based on the translation provided by D/Sgt Rose is as follows:

V[REDACTED]-A[REDACTED] and Aguilar-Lara had been dating on and off share the mutual child, [REDACTED]. She has legal custody from the Family Court of Ocean of the child and Aguilar-Lara may only see the child under supervision. She stated that she was attempting to

get the child's Social Security card so she could attempt to get away from Aguilar [REDACTED]. She admitted that she did not tell him why she wanted the card as she did not want a negative reaction.

On March 7th, 2023, she and Aguilar-Lara agreed to meet to exchange paperwork. Early afternoon, Aguilar-Lara showed up in his Chevy Equinox and left with C [REDACTED]-A [REDACTED] and the juvenile. She quickly saw alcohol in the cup holder and believed that Aguilar-Lara was intoxicated. After driving around, he drove her back to her residence at 75 North Hope Chapel Road in Jackson around 2248 hours with the intention to exchange paperwork (child's Social Security Card for paperwork he left behind previously). He made mention that he believed that she was trying to keep the child from him on the ride back to the residence. When she arrived, V [REDACTED]-A [REDACTED] left the vehicle to get the paperwork and Aguilar-Lara quickly sped out of the driveway and away from the residence. V [REDACTED]-A [REDACTED] began to run after the vehicle while using her phone to call 9-1-1 and yell for help. At the traffic light the vehicle was stopped and she was able to catch up to the vehicle, but when she came upon the car, Aguilar-Lara exited the vehicle, grabbed V [REDACTED]-A [REDACTED] and pulled her into the vehicle before driving away.

V [REDACTED]-A [REDACTED] advised that she was being physically struck by his fists and that he pulled her hair, not allowing her to leave

the vehicle. She stated that when approaching lights or stop signs he would avoid stopping so she could not exit. She stated that multiple times she attempted to get to the back seat where the child was and was pulled back to the passenger front seat. She advised that Aguilar-Lara took her cellular phone and when 9-1-1 called back, he told her to use a fictitious name, which she did not. He kept her phone and would cycle from airplane mode to cellular to see who was texting her and to respond.

He arrived at an apartment in Toms River and kept her phone, but allowed her to enter the residence with the child to use the restroom and then return to the vehicle. He drove around Toms River in the Route 37 area and decided that he would let the victim go by calling her a ride only after she agreed to lie to police. He coached her on exactly what she would say to police multiple times. Shortly after, Toms River Police made contact and he ran from the area of the vehicle and she was able to run up to the window of another Toms River Police vehicle for assistance.

A [REDACTED] V [REDACTED] - A [REDACTED] advised that in the past, she has filed restraining orders against Gerson Aguilar-Lara but never followed through after she received threats from Aguilar-Lara by using others to pass along messages.

Supervising Assistant Prosecutor Kristin Pressman was advised of the facts of the investigation and approved criminal complaints for two counts of kidnapping, robbery, and endangering the welfare of a child.
