1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On 9/17/23, officers responded to the area of Bahia Ct. in Brick for the report of multiple burglaries to vehicles. On arrival, officers canvassed the area viewed surveillance video from multiple neighbors. Video showed the suspects arrived in a dark colored BMW sedan at 2040 hours. One suspect can be seen wearing what appears to be a black a gray sweatsuit, and either gaining entry or attempting to gain entry to vehicles parked at 8 Bahia Ct, 5 Bahia Ct, and 2 Catalina Drive. The Ocean County Sheriff's Department CSI responded to the scene and processed the victim's vehicles for fingerprints. Those fingerprint samples were then sent out for analysis, and it was confirmed that Ahmad Singletary (DOB 5/30/1999) was a positive match on each of the victim's vehicles. Patrol units later responded to 10 Halsey Drive, 11 Halsey Drive, and 13 Halsey Drive for similar vehicle burglary reports. Video surveillance showed the same suspect vehicle arrive to the area at 2025 hours, driving down the street without headlights or tail lights activated. The suspects then exit the vehicle and gain entry into vehicles parked in each victim's driveway.
