1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:
On 09/15/23, Brick Township Police officers responded to the neighborhood of Cherry Quay for reports of motor vehicle burglaries, a motor vehicle theft, and an armed burglary to a residence. On arrival, officers were advised that suspects entered into a vehicle at 142 Port Rd and stole a police vest and police radio, stole a Jeep Cherokee from 179 Royal Drive, and attempted to get into a residence at 10 Royal Drive while armed with a handgun. I, Det. Farnkopf, was able to review surveillance video from each incident, and determined the suspect vehicle (BMW X7 NJ Reg [REDACTED]) was stolen out of Sayreville, NJ. Additional incidents of motor vehicle thefts and burglaries were reported on 9/17/23 and 9/25/23 in Brick Township, where Ahmad Singletary was determined to be the suspect. During an interview of Singletary following an arrest on 9/25/23, where he was taken into custody while operating a vehicle stolen out of Brick, NJ, Singletary made admissions to being in the stolen BMW X7 suspect vehicle on 9/15/23. Also at the time of Singletary's arrest, he was in possession of a 9mm Ruger handgun. Both Singletary and the handgun matched the suspect description on the 9/15/23 incidents.
