Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.					
1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed <u>and</u> (2) the defendant is the one who committed it: I conducted a motor vehicle stop on [REDACTED] for several motor vehicle violations, including failure to maintain lane, delaying traffic and for having tinted front windows. A registration inquiry revealed the registered owner had a suspended driver's license. The operator and registered owner, Dwight E. Gooden, appeared to be under in the influence. After standard field sobriety tests were conducted, Gooden was placed under arrest for Driving While Intoxicated and for Driving While Suspended. I observed the interior of Gooden's nostrils to be covered in a white-powdery residue. Two green, plastic zip-lock style baggies were located in the vehicle that contained a white-powdery substance believed to be cocaine. The baggies were located on the driver's side floorboard and under the driver's seat.

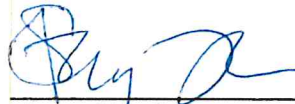
FIRST COUNT
