Purpose This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On 10/17/23, this Affiant advised that the father of the [REDACTED], Paul Hogg, reported to Jackson Township PD that the victim disclosed to him that she was involved in an inappropriate relationship with her mock trial teacher, Andrew Fantasia (DOB: 08/29/1996), during her senior year of high school. The teacher was the victim's math teacher and later became the victim's mock trial coach. Hogg advised that the victim disclosed that she and the defendant touched each other and sent nude photographs. Hogg advised that the victim was currently undergoing evaluation for mental health issues.

On 10/25/23, Det. Kaiser and this Affiant conducted an interview of the victim, [REDACTED], who advised that between February and June of 2023 during her senior year at Jackson Memorial High School, the victim engaged in sexual contact with the defendant, specifically by kissing, touching the victim's breasts and buttocks, and having the victim touch the defendant's penis over the clothes. [REDACTED] also disclosed that the defendant would request that [REDACTED] send nude photographs via Snapchat. The victim described that the defendant directed [REDACTED] on what to do to herself in said photographs. [REDACTED] advised that the defendant would save the photographs into a locked album in Snapchat on his black I-Phone. [REDACTED] advised that the defendant would instruct [REDACTED] as they masturbated to each other over the phone. [REDACTED] advised that [REDACTED] and the defendant communicated via text message, Discord, and Snapchat.

On 10/25/23, Det. Kaiser and this Affiant interviewed the mother of the victim, Christine Hogg (DOB: 9/29/1972). Ms. Hogg stated that the defendant was [REDACTED]'s former math teacher and mock trial coach. Ms. Hogg advised that on 10/15/2023, the defendant text messaged her advising concern for the well-being of [REDACTED]. Ms. Hogg stated that the victim disclosed that the defendant would pull [REDACTED] into his classroom alone, put [REDACTED]'s hands on the defendant, had [REDACTED] send inappropriate videos, and kissed [REDACTED].

2. I am aware of the facts above because: (Included, but not limited to: your observations, statements of eyewitnesses, defendant's admission, etc.)

On 10/25/23, [REDACTED] agreed to and signed a consent to assume telephonic presence form in order for Det. Kaiser to attempt to elicit a conversation with the defendant regarding the allegations. [REDACTED] provided the telephone number for the defendant [REDACTED]. During said conversation, the defendant acknowledged that sexual contact occurred while [REDACTED] was a student and said acts occurred in the classroom. 1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On 10/17/23, this Affiant advised that the father of [REDACTED], Paul Hogg, reported to Jackson Township PD that the victim disclosed that she was involved in an inappropriate relationship with her mock trial teacher, Andrew Fantasia (DOB: 08/29/1996), during her senior year of high school. The teacher was the victim's math teacher and later became the victim's mock trial coach. Hogg advised that the victim disclosed that she and the defendant touched each other and sent nude photographs. Hogg advised that the victim was currently undergoing evaluation for mental health issues.

On 10/25/23, Det. Kaiser and this Affiant conducted an interview of the victim, [REDACTED], who advised that between February and June of 2023 during her senior year at Jackson Memorial High School, the victim engaged in sexual contact with the defendant, specifically by kissing, touching the victim's breasts and buttocks, and having the victim touch the defendant's penis over the clothes. [REDACTED] also disclosed that the defendant would request that [REDACTED] send nude photographs via Snapchat. The victim described that the defendant directed [REDACTED] on what to do to herself in said photographs. [REDACTED] advised that the defendant would save the photographs into a locked album in Snapchat on his black I-Phone. [REDACTED] advised that the defendant would instruct [REDACTED] as they masturbated to each other over the phone. [REDACTED] advised that [REDACTED] and the defendant communicated via text message, Discord, and Snapchat.

On 10/25/23, Det. Kaiser and this Affiant interviewed the mother of the victim, Christine Hogg (DOB: 9/29/1972). Ms. Hogg stated that the defendant was [REDACTED]'s former math teacher and mock trial coach. Ms. Hogg advised that on 10/15/2023, the defendant text messaged her advising concern for the well-being of [REDACTED]. 2. I am aware of the facts above because: (Included, but not limited to: your observations, statements of eyewitnesses, defendant's admission, etc.)

On 10/25/23, Det. Kaiser applied for a telephonic search warrant to the Honorable Guy P. Ryan for the residence (609 Beach Ave, Beachwood, NJ) and vehicle (2015 Toyota Corolla NJ Reg: [REDACTED]) belonging to the defendant and the persons of the defendant for all cellular phones and electronic devices. Said telephonic warrants were approved by the Honorable Guy P. Ryan on 10/25/23 at 1814 hours.

On 10/25/23, contact was made with the defendant at his residence and advised of the active search warrants. The defendant advised this Affiant and Detective Kaiser that he did not wish to speak about the allegations without a lawyer present. Det. Kaiser then contacted Assistant Prosecutor Victoria Veni and reviewed the facts of the case. At 1925 hours, AP Veni approved the charges of 2nd degree Official Misconduct, 2nd degree Endangering the Welfare of a Child, and 3rd degree Aggravated Criminal Sexual Contact.

3. If victim was injured, provide the extent of the injury:

This Affiant and Det. Kaiser then executed the search warrants for the persons, vehicle, and residence belonging to the defendant. One (1) cellular phone and three (3) laptops were seized during said search warrants.

On 10/30/23, Det. Kaiser applied for and was granted search warrants for the cellphone and three (3) laptops belonging to Fantasia. Sgt. Coles of the OCPO/HTCU conducted a full forensic analysis of these devices. On Fantasia's Apple I-Phone 14, three (3) images were recovered of a naked female from 4/7/23.

On 11/1/23, Det. Kaiser and this Affiant presented [REDACTED] with said naked photographs, of which she positively identified as herself, and advised that the defendant directed/requested [REDACTED] to take said photographs with the purpose of sending to the defendant.
