Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On 06/03/2024, I was investigating a bird being trapped in a cardboard box, which appeared to have been purposely done by an individual at Forge Pond Park (808 Route 70). While checking the park, I observed a hammock hung between two trees with an individual sleeping inside. I made contact with the individual, who stated his name was Doug. I asked this individual for his full name and date of birth, and he stated his name is Doug Long and his date of birth is 03/05/1991. This pedigree information was given to police communications, yielding negative results for the information given. The individual stated he does not know his social security number, that he previously had a driver's license in Virginia, and that he did not have his wallet. Units later observed the individual attempt to discreetly pick up his wallet off of the ground and place it in his rear pocket. The individual eventually took out his wallet and produced a New Jersey driver's license, and he was identified as Christopher Therien. Christopher stated that he may have a warrant, and police communications checked him for outstanding warrants, which yielded numerous warrants for his arrest and that he was entered as missing/endangered. After receiving the confirmation for the outstanding warrants, I approached Christopher, and as I took a step towards him he turned and sprinted towards Forge Pond. I pursued Christopher on foot, but he went into Forge Pond and began swimming across towards Forge Pond Road, where he stole a blue two-seat kayak, valued at approximately \$900.00, containing a blue life vest, valued at approximately \$80.00, and a red paddle, valued at approximately \$40.00, from M.B. 's backyard. Christopher continued into Forge Pond away from units utilizing the stolen kayak. A department drone was deployed which located Christopher in the kayak on Forge Pond. Utilizing the department drone, Christopher was given verbal commands that he was under arrest and to not move. Christopher continued to utilize the stolen kayak to travel on Forge Pond.
