Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On July 1, 2024, the Director of Human Resources at the Wall Township Public Schools contacted the Wall Township Detective Bureau to report a possible inappropriate sexual relationship between a former student and a Wall Township Highschool teacher. The teacher, Julie A. Rizzitello was reported to be having a sexual relationship with the 18-year-old victim, [REDACTED], while he was a student at the school. Formal Statement were taken from [REDACTED] during which he detailed a romantic relationship he was having with Rizzitello starting in April of 2024. On May 18th, 2024, [REDACTED] reported that he had oral sex and sexual intercourse with Rizzitello in his vehicle in Brick, NJ. [REDACTED] reported that he and Rizzitello continued to have sexual intercourse/sexual contact on multiple occasions between April 2024 and June 14, 2024. The sexual conduct occurred in Wall Township, Belmar and Brick. He also reported that Rizzitello sent him nude photographs of herself following the first time they had sexual intercourse. [REDACTED] provided Consent to Search of his cellphone which revealed numerous communications and photographs between Rizzitello and [REDACTED] that were sexual in nature. He also reported that he disclosed his relationship with Rizzitello to several of his friends.

Additional formal statements were obtained with several witnesses who also detailed their knowledge of Rizzitello's relationship with [REDACTED] and corroborated [REDACTED] disclosure.
